**MEXICO BEACH CITY- US HWY 98 LANDSCAPE RESTORATION**

The US Hwy 98 Landscape Restoration consists of constructing approximately 1.22 miles of landscaping that is approximately 100 feet wide that was washed away by Hurricane Michael. The restoration will also include the construction of a 6" watermain and miscellaneous irrigation along the same length as the landscaping. The project is located along the Gulf of Mexico side of US Hwy 98 from 8<sup>th</sup> Street to CR 386 in Mexico Beach, FL.
